 - a. Determine Theme
 - i. Proposed themes were discussed

 - i. David suggested that we really make a push for getting more students (counselors of tomorrow) to the conference
 - ii. Kay still has some "Save the Date" cards left over from ICA Conference that we can use

 - iv. Vickie will send the information via email to the Boise State counseling students
 - v. Jennifer will help Amy get the registration up on the website
